Director, Contract Admin	Responsible for the overall management of the transportation and storage contract administration process for all of SET U.S.'s pipelines and storage facilities, as well as M&N Canada. Facilitates the resolution of inconsistencies between different SET US pipeline and storage entities with respect to transportation, storage and discount contract administration systems, processes, and tariff language, in order to ensure the most efficient compliance and control mechanisms across SET US. Serves as a primary customer interface on complex contractual issues, particularly those involving questions associated with capacity posting requirements, net present value calculations, and contractual rights of first refusal. Oversees the design, testing, and implementation of changes to the pipeline and storage system contract administration-related programming code. Oversees account management of Texas Eastern's SCT customers.

This position requires a minimum of two (2) years progressive gas control or equivalent related industry experience required.
Gas Systems Controller, Associate	Reports to the manager of gas control. This position is responsible for a 24 hour per day monitoring and control. Keep supervisors and management apprised of situations affecting the system. This is an entry level position and requires with no experience.
Gas Systems Controller, Principal	Reports to the manager of gas control. Prepares reports, studies and related information. Ensures other gas controllers are aware of assist in the planning of facility outages affecting each shift. Observes daily work activities of gas controllers and trainees and provides advice, direction and conducts OTJ training. This position requires Five (5) years progressive gas control or equivalent related industry experience required. Demonstrated ability to perform complex job functions with limited direction.
Gas Systems Controller, Shift Leader	Reports to the manager of gas control.
